CORPORATE CONFLICT MINERALS POLICY

Serigraph is committed to the ethical sourcing of components and materials used in our products and are currently in the process of assessing whether any of our products contain Conflict Minerals from the Covered Countries. Our goal is to refrain from purchasing components and materials containing Conflict Minerals from the Covered Countries, unless those materials are certified by an independent third party to originate from conflict-free sources.

Based on our assessment to date, we do not directly purchase any Conflict Minerals, but we have found them to be present in certain components that we purchase from suppliers and incorporate into our products. The global supply chain for these components is very complex, and tracing the minerals in these components to their source is challenging. We are working diligently with our suppliers and other stakeholders to confirm that the Conflict Minerals in any supplied components or raw materials do not finance the continued conflict in the Covered Countries.
